INSTRUCTIONS FOR FEEDING:

Triple Trust® Sheep Mineral is a 2 to 1 calcium to phosphorus mineral to be self-fed to sheep or mixed with the roughage or grain portion of the ration. One (1) ounce of this product provides 0.7 mg of supplemental selenium.

SELF-FED FEEDING: Feed at the rate of 1 ounce per head per day. Provide one covered mineral feeder for every 20 to 25 animals. Mineral feeders should be located near a clean, fresh source of water. Mineral intake will vary depending upon the mineral status of the sheep. If intake exceeds 1 ounce/head/day reduce the number of feeding locations and/or move them further from water and loafing areas. If intake is less than 1 ounce/head/day increase the number of feeding locations and/or move them closer to water and loafing areas. Provide clean, fresh water at all times.

MIXING DIRECTIONS: Thoroughly mix **Triple Trust® Sheep Mineral** with other feed ingredients to make one ton of supplement providing no more than 0.7 mg of selenium per head per day.
